Transparency, Legislation, and Project Asclepius

The Milo Tello Representative Team has one sole goal in mind for the betterment of Los Santos; Transparency. We as a team see transparency differently than other Representatives and Candidates because they lack the potential for general population interaction. In the past, transparency was defined within the state plainly as 'we keep you up to date with what is going on' and not as much as 'we will take into and potentially front your opinion for change within the state.' So what would this mean for citizens of Los Santos? It essentially boils down to 'your opinion matters' and we take that seriously as a team. Public opinion is one of the largest sole bodies that can influence change and we wish to embrace that, not as a threatening body but as a potential for the greater good. We are wishing to hold our own publicized polls open to any citizen within the state regardless of potential criminal record to see where the general population stands on specific bills, legislation changes, and much more. We don't want to stop there.

As of the holiday season, drug related crimes have been climbing higher and higher within the state to the point where it may be seen as a problem of public safety. We as a team have created a rejuvenation and recovery program we would like to officially make public. Introducing 'Project Asclepius,' where we open the door to a safer, and cleaner Los Santos for everybody.

You might be asking yourself, "Isn't that just rehab with more steps?" The short answer? No, it is more astounding than rehab. Our vision of Asclepius is to work hand in hand with local business owners who wish to enter with us, and local law enforcement and the Department of Justice to help people turn their lives around with help every step of the way. We want to (with the help of the DOJ) introduce a new alternative to imprisonment for people who have been arrested on drug charges or are victims of drug abuse who want a fresh start.

With Asclepius, it is our goal to help people find a place that is safe and clean for them to have a fresh start. With collaboration with local businesses, we will work with owners of said business to put people into the workforce with some monitoring. An example of this would be as such: "John Doe was arrested on a narcotics sale charge but requested to be put into Asclepius instead of serving jail time for his actions. When Doe had approached us with his

situation, and with clearance from the DOJ, we managed to get him working at the local pizza restaurant. He has been working strongly at the restaurant and made a complete 180 of his life in a safe way without narcotics."

The next step would be participant confidentiality within Asclepius. Any and all documentation for both staff and participants is to remain completely confidential at all times. No outside parties can request any information on the aforementioned subjects unless certain circumstances are affecting a participant, those being but not limited to; participant request, relapse, indictment of narcotics related arrests, or per Department of Justice request that coincides with an indictment or narcotics related arrests.
